a. Tom (alumni)

i. Community Week

b. Alfie (domestic)

i. Vac Res Update

- Alfie → Have worked on a draft for the policy, please take a look at link sent on the group chat and let me know if there are any issues with it.
 - Going through the proposal in the welfare council with Tilly on the 21st, on the agenda already. Simon can bring it up in the general council the day after on the 22nd.
 - Fab has brought up that we might also want to negotiate lowering the cost of rent or eliminating paying completely if vac res is granted on welfare grounds, but it would be better to fight one battle at a time, maybe can work on this later down the line. For now, stick with just granting vac res in the first place.
- Ayesha → Will the doctors really give recommendations for vac res?
